

UNE Partnerships offers fee-free training in infection prevention and control

To support the re-opening of customer facing businesses and ensure that staff are implementing the highest safety standards, UNE Partnerships (RTO No. 6754) will deliver four **Infection Control Skill Sets, FEE-FREE**. This training is funded by NSW Government and is available to employees, managers, retrenched workers, job seekers, and persons in secondary education (excluding those already participating in VET schools' programs).

Targeted priority industries for the fee-free training are retail, food and beverage, tourism, hospitality, cleaning, security services, transport and logistics, aged care, and disability care. Other customer facing businesses are encouraged to participate.

As an approved provider of the training, UNE Partnerships is required to submit an Expression of Interest (EOI) application for fee-free training places on behalf of our clients and industry by **Monday 20th July 2020**.
